042221- On 4/21/21, [REDACTED] called regarding his daughter being stopped on traffic due to wrong information regarding her license plate showing up as stolen. [REDACTED] said his daughter [REDACTED] and her passengers were treated like criminals and harassed about drug use. [REDACTED] said the juveniles were good kids and students.

On 4/22/21, there was a call from the complainant [REDACTED] who was upset that her daughter [REDACTED] was treated like a felon and traumatized by the officers. [REDACTED] said her daughter was also harassed about possible drug usage.

I spoke with [REDACTED], who felt a mistake in a police report, which led to her daughter and [REDACTED] daughter being stopped was completely unacceptable. [REDACTED] also felt the way her daughter and others were treated was also unacceptable. [REDACTED] felt that four cruisers at the scene was excessive. [REDACTED] said she was never notified that the officers had stopped and had contact with her daughter. [REDACTED] said her daughter is now traumatized by the incident and doesn't trust the police. [REDACTED] identified Ofc. Aikman as the officer, who harassed her daughter.

\*\*\*It should be noted [REDACTED] talked about another incident involving her son, which is a different complaint\*\*\*

I also spoke with [REDACTED], who said he just wanted to talk to the officers involved in the incident to understand what happened. He didn't wish to file a complaint. [REDACTED] said his daughter said Ofc. Aikman was very respectful toward her. [REDACTED] said Ofc. Aikman had called and told him about the stop and explained what happened. [REDACTED] also said he, his daughter and the officers involved are going to meet on 4/26/21 to discuss what happened- This was also Ofc. Aikman's suggestion. [REDACTED] said that was what he wanted and he didn't wish to file a complaint.-CCI Theresa Person (6330)
