Summary:

On December 27, 2025, at 12:11AM, Officer's D. Green and [REDACTED] responded to [REDACTED] for a reported kidnapping where the victim said the suspect threw gasoline on her and threatened to set her on fire.

At 1:02AM I sent Officer Green a text asking him if he was good on the CFS. After a couple of ambiguous responses, I called him directly. After a few direct questions in regard to the victim having gas thrown on her and if the suspect made any threats, Officer Green conveyed that did not happen and the victim just wanted the suspect trespasses from the property. I advised Officer Green to document details in the call screen. Officer Green cleared the call with no report taken.

At 10:12AM day shift officers responded back to the location where the suspect returned to. Officers established probable cause for felony charges stemming from the original CFS Officer Green had responded to.

On 1/2/26, I, Lt. Van't Land/3526, in-processed this complaint. I classified (2) BWC videos for the two subject employees as Complaint related. I reviewed some portions of Offc. Green's BWC and noted the victim did in fact tell Offc. Green that the suspect had thrown gas on her. She also stated she turned over the keys because the suspect had threatened to shoot her nephew earlier in the day, and she also mentioned that the vehicle was stolen. Because Offc. Green heard about 3 potential felony crimes and did not relay that to [REDACTED], it appears that a potential relevant policy violation is Employee Conduct.

On 1/5/26, Cmdr Snuggs advised that after review with DC Rosenoff, this will be further investigated as a Level 2. I assigned it to Sgt. Van Ooyen. --av/3526
