Summary:

On 4/17/24 the Internal Affairs Unit was contacted by a complainant identified as [REDACTED] (DOB: 10/03/95). The complainant stated that their vehicle was parked in front of their house on 4/10/24 and it was hit by another vehicle that did not stop to provide any information (hit and run). Officers responded to the complainant's residence and initially refused to help the complainant at all. The complainant stated that officers refused to do any work, so the complainant had to conduct the hit and run investigation on his own. The complainant was able to obtain dash cam video from a witness and provided that to the officers. Officers took a report for hit and run but refused to do any follow up to the investigation. The complainant was able to view the dash cam video, determine the correct license plate of the vehicle, and identify the vehicle from the license plate. The complainant feels that he had to do the investigation for them and that the officers did not want to do their jobs and complete the investigation themselves.

Then the complainant learned that on 4/15/24 Officer D. Green contacted the hit and run suspect who met with him at the Gold Hill Substation. Officer Green issued the hit and run driver a summons for Careless Driving and did not charge the appropriate hit and run charges that the complainant felt were applicable. The complainant feels that the officers who worked this investigation initially refused to do any work or follow up,

that he had to do the investigation on his own, and that when the hit and run driver was contacted they were not charged appropriately.
