Inmate [REDACTED] submitted a letter to the "Professional Standards Unit" annotating several complaints regarding the kiosk, Michigan prison staff, corruption at CJC, [REDACTED] and Deputy D. Smith.

Inmate [REDACTED] claims he was assaulted by Deputy Smith in the ward and Deputy Smith stole and destroyed his coffee.

I hereby state that the information provided by me in this complaint is true and correct. I understand that if an investigation reveals that I have knowingly provided false or misleading information, I may be subject to criminal charges under 18-8-111 punishable by up to 120 days in the El Paso County Jail and/or a \$750 fine.

Dear Professional Standards Unit,

I am writing to you because Administrative Conditions at C.J.C. have rendered the Administrative Services Kiosk and Grievance System worthless.

I used to work in the kitchen. So, I know Trinity's FUSION network allows them to access inmate information accross the Nation -- and alter (update) it.

I also know VitalCore is owned by Thrive-Next-Gen-Communications and is using (or illegally crossing their network with) Trinity's network.

Michigan Prison Staff are doing religious diets -- Tele-Link, -- and remotely practicing medicine accross State Lines.

These are not accusations, but corporate facts Headquarters will sweat by! We offer exactly this service that you bought!

The Problem is, Inmate Accounts can be red flagged and their Grievances redirected.

Trinity employees are answering Grievances, redirecting Communications, and the Deputies are glad to see them do it -- to save your lazy lieutenant's time.

The corruption in CTC is to be expected: but crippling Administrative Services so it is just an out-of-State Denial of Service System?

In this way deputies are able to keep their Chain of Command totally ignorant of their wrong doing.

I would now like to share my official, Professional Standards Complaint against Dep. D. Smith for his conduct on May 22, 2026 at approx. 830pm in ward G-2.

I work in the Kitchen. After receiving Commissary, legal mail, settling back in after work, I got in the Shower.

Med. pass came.

At some point Dep. Smith became upset. Probably because of the noise. He has a reputation among the inmates of being cruel and serially abusive. Not even his co-workers like him.

He shined ~~in~~ a flashlight like a strobe at the Shower. Having no concern for the fact I have a [REDACTED] and history of [REDACTED].

I looked out and saw he wanted me out of the Shower. So I dried off and returned to my bunk. I had not left the Shower out of consideration for the nurse.

I also feel working 60 hours a week in the Kitchen so the deputies don't have to afford me the Human Right and Divine Dignity to take a Shower and be clean without having to beg a deputy for my God Given Rights to Human Respect.

We all unlocked. Smith saw me walking laps and using the kiosk for some 20 minutes. There was no problem.

I approached his desk, and he blew up at me and immediately told me to pack my stuff. So I began to pack.

I returned to ask for a trash bag. He denied me.

So I kept packing. Returned again to ask for a trash bag. He denied me. I did flip him off and say "Do you have any Professional Standards? How do I write Professional Standards? 27 E. Vermijo?"

He became immediately violent shouting obscenities.

I returned a last time to ask for a trash bag, and he bolted across the room and needlessly assaulted me. It was 3rd Degree assault, it was Unwarranted and the Colo. Gov. Immunity Act only protects against civil liability, not criminal prosecution.

I laid on the floor as he screamed at me to get up: Deputies rushed in to remove me.

I sat in the Sally Port Holding cell for an hour until I was moved to Unit G-4, across the hall.

During that time, someone went in my Property (~~that~~ that was in the middle of E-Bay, in Plain View of the Camera) and removed three bags of Coffee.

~~All~~ All my books and legal papers from the same location were given to me: But the coffee is gone.

Also from my locker Two Toothpastes a Deodorant and Lotion were stolen: But the rest of the locker arrived.

I have repeatedly asked deputies to review the cameras to be denied. This makes me believe the event was retaliation for my suit against [REDACTED] and Deputy Smith destroyed the coffee himself.

From what I know about [REDACTED], absolutely Nothing

happens in this Dept. without the Commander and his echelon heads at CJC having full knowledge and intention behind it.

Which is why I am writing you today: To request a Professional Standards review of [REDACTED] because of the Absolutely broken State of Administrative Services, Medical, the Grievance System, and Trinity's Usurpation of this Jail.
