#### Summary:

On 5/21/20 at approximately 1800 hours ██████ called the Gold Hill Duty Desk very upset about how officers handled a possible child abuse. ██████ related officers had responded to her residence at ██████ regarding a 10 year old boy who was at her residence reporting he had been burned, strangled, and was not being fed. ██████ does not know the child or his family, stating he showed up at her house. ██████ was outraged over how the officers responded saying they were not compassionate or caring. She also said they were not doing anything to help the child. ██████ said one of the officers said the child had been abandoned by his mother 8 years ago causing the child to cry. ██████ demanded officers remove the child from his home, force DHS to do something, and take action. ██████ also alleged the officers were investigating fully because she and the child are not white and the officers are. She demanded the officers involved be removed from the case stating she would call my boss and any other boss every day until something was done. She demanded to know the outcome of the child abuse case and the outcome of my conversation with the officers. When I wasn't clear whether she wanted to file a complaint against the officers I asked her. ██████ said she did want to file a formal complaint.

I explained to ██████ I could not divulge the details of the alleged child abuse, but did explain we had been involved with the family the last few months as had DHS. I tried to explain there was additional information she was not aware of in an attempt to reassure her the allegations were and have been investigated in the past. ██████ continued to talk or yell over me. I did record the phone call on my Department issued cell phone using the voice memo function. The recording was interrupted when I received an incoming call. I resumed the recording as soon as I declined the phone call. The two recordings are attached. The original CFS from ██████ is also attached.

I reviewed the CFS noting ██████ and Officer Isabell Koperecki 6809 responded to ██████. ██████ is familiar with the 10 year old boy ██████ called about. He has responded to numerous calls involving the 10 year old child, his two brothers and the Aunt, who has custody of the boys. See premise history for ██████ for details.

I also reviewed the BWC footage of ██████ and Officer Koperecki. The BWC footage shows ██████ to be very animated and upset at the situation. ██████ repeatedly tried to explain to ██████ he is familiar with the child as well as the allegations. He also tells her he will investigate the allegation the child is making today. Neither officer was rude or unresponsive. ██████ was not satisfied with the officers responses. After the officers leave ██████, ██████ interviews the child about his allegations before returning to the child's home

to continue the investigation. [REDACTED] responds to the child's home as well to assist the officers.

After reviewing the BWC footage, I find this complaint is unfounded by BWC.
