6) Use of Force Narrative

On August 4, 2022, Deputy Beltran, Jamie [REDACTED] was supervising inmates in Unit 24 that had come from Unit 21 to complete their two hours out for the day. At approximately 1430 hours, Inmate [REDACTED], [REDACTED] were in the shower area. Deputy Beltran heard "scuffling noises" coming from the shower area, so he went to investigate. Deputy Beltran found Inmate [REDACTED] and Inmate [REDACTED] grappling and trying to "wrestle each other to the ground" Deputy Beltran called a "Code 5 to Unit 24". Deputy Beltran, to prevent the inmates from continuing to fight and

potentially injure each other, drew his OC, and loudly commanded the inmates to "Stop fighting!". Deputy Beltran aimed his OC at the inmates, and they complied with his command. Deputy Beltran instructed Inmate [REDACTED] to stand by the phones and she complied. Deputy Wetsch, Daniel [REDACTED] responded to the code 5 call. Deputy Wetsch instructed Inmate [REDACTED] to place her hands behind her back and she complied. Deputy Wetsch placed Inmate [REDACTED] in handcuffs and took her to the VPRO room. Inmate [REDACTED] was on the ground in the shower. Deputy Beltran told her to stand up and take the gloves off she was using to clean the showers. Deputy Beltran instructed her to place her hands behind her back and she complied. Deputy Beltran placed her in handcuffs. Inmate [REDACTED] was escorted to Cell 4 and secured inside.

At approximately 1432 hours, Nurse Andrew Ellquist arrived at the unit to assess the inmates. Both inmates declined to be assessed, stating they were not injured, and were cleared to remain in the facility.

#### 7) Medical

At approximately 1432 hours, Nurse Andrew Ellquist spoke with both inmates and attempted to assess them. Both inmates refused to be assessed by Nurse Andrew, stating they were not injured. Neither inmate reported any nor did they have any visible injuries resulting from the use of force. Both inmates were cleared to remain in the facility. No involved deputy reported any nor did they have any visible injuries resulting from the use of force.

#### 8) Restraints

Inmate [REDACTED] was placed in handcuffs at approximately 1431 hours. Inmate [REDACTED] handcuffs were removed at approximately 1443 hours when she was secured in her cell in Unit 21. Inmate [REDACTED] was placed in handcuffs at approximately 1431 hours. Inmate [REDACTED] handcuffs were removed at approximately 1445 hours when she was secured in her cell in Unit 21.

#### 9) Conclusion

All force used was reasonable, appropriate, and necessary. Deputy Beltran's threat of OC caused the inmates to stop fighting and prevented them from continuing to harm each other.

No post recommendations necessary.

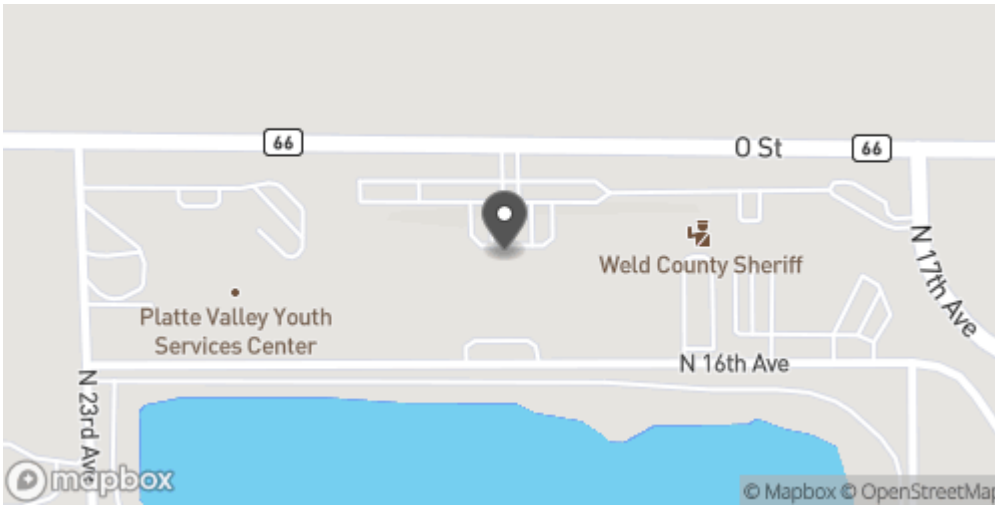

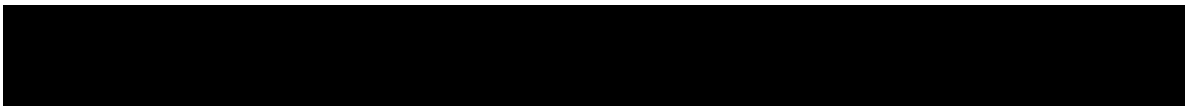


Location of Occurrence NJC 2W UNIT 24

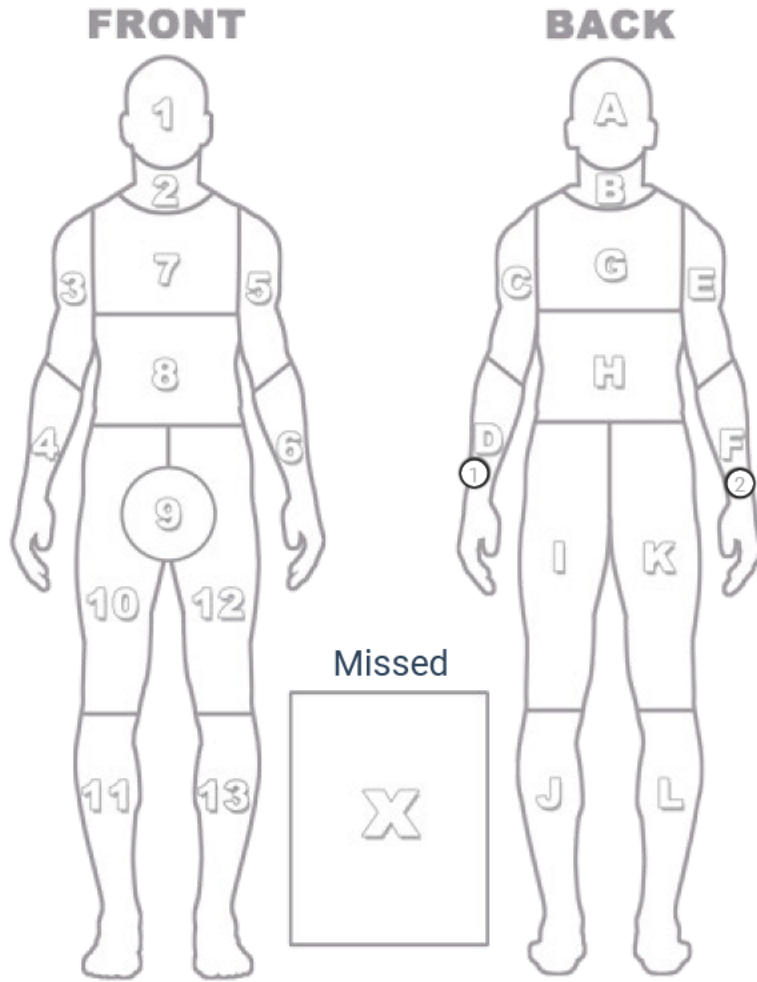

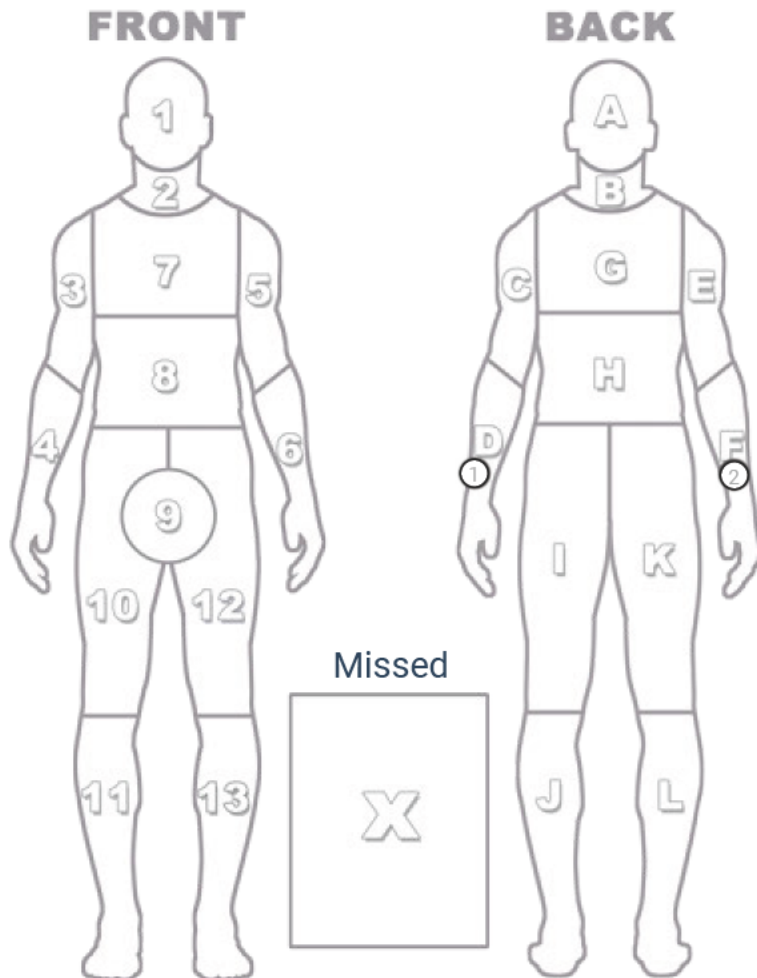
