Summary:

Complainant came into Stetson Hills Lobby due to his Husband advising him that he was reporting him for a Sex Assault. while speaking to the complainant, he indicated that he had reported a sex assault to officers on 06/23/25 and they had advised him that since it didn't happen in Colorado Springs, that they couldn't take a report. Complainant indicated that he had advised the officers that his husband had performed oral sex on him while he was asleep without his consent and that this occurred 3 times. He indicated that he woke up all three times and told him no and to stop and he did not consent to this occurring. Complainant stated that he had advised the officers that this occurred in Michigan City Indiana but they dismissed him and "re-victimized" him. The complainant indicated that he asked that the officers take a report and he understands that it cant be prosecuted here, he just wanted it documented about what happened. Call Screen is attached.

On 6/26/25, I, Lt. A. Van't Land/3526, did the intake of this complaint at IA. I classified relevant BWC as complaint related and released it to the chain. It can be released to any assigned supervisor.

On 08/21/25, Internal Affairs received a phone call from [REDACTED] requesting an update for this case. I, Officer B. Kerfoot/6604, spoke with him and informed him the case was still open and actively under investigation. [REDACTED] expressed concern over how long the investigation was taking. I reminded [REDACTED] he could call the number of the Stetson Hills Commander for any questions regarding the investigation, as what was listed in his intake letter. [REDACTED] stated he also just wanted to make sure the case had not been closed without any resolution having been provided to him. I reiterated the case was still open and under investigation.

On 08/24/2025, I, Sgt. Hwang/3960, attempted to call [REDACTED] to update him on the investigation and left a voicemail with my direct contact information. as of 08/30/2025, [REDACTED] had not returned my phone call.

On 9/15/2025, Cmdr B. Cummings advised me, Lt. A. Van't Land/3526, that he would like this PI25-0227 converted to a Level 2 that the chain of command would investigate, as it pertains to a pattern of Work Performance with subject officer Johnson-Dean. --avl/3526

On 09/15/25, I, Officer B. Kerfoot/6604, sent notice to the Complainant via email that the investigation of his complaint had been moved up to a more serious level of investigation, and therefore, the investigation would take more time to conduct. I suggested the Complainant reach out to Commander Cummings of the Stetson Hills Division with any questions regarding the investigation.

On 10/21/25 [REDACTED] called the IA unit inquiring about the status of the investigation, why it was taking so long, and why the Intake Letter he received had the wrong IA case number printed on it. [REDACTED] wanted to add to his complaint that he felt CSPD was generally incompetent. On 10/21/25 Sergeant J. Thurman #5101 emailed [REDACTED] and explained that he was contacted by another Administrative Assistant and informed that his case was elevated from a Preliminary Inquiry to a Level 2 Investigation, and that it is not the practice of the department to provide the complainant with the new corresponding IA case number. On 10/22/25 Sergeant Thurman forwarded the aforementioned email to me, CCI Strachan 1778. On 10/22/25 I attached the email and a recorded phone call placed by [REDACTED] to the IA unit to this complaint.

On 10/22/2025 @ 2259 hrs, I provided the disposition to [REDACTED]. He was also provided my direct business number again and stated he may have missed my message left on 08/24/2025.
