052820- On 5/26/20 The complainant left a voicemail on the Internal Affairs main line. He wanted to file a complaint against Sgt. Chadbourne for how he was treated. The complainant said he felt harassed by Sgt. Chadbourne, who had followed the complainant into a 7-11 and made degrading comments to him.-CCI Theresa Person (6330) 052820

060820-On 5/28/20, I spoke with the complainant, who was upset with that the officers were improperly blocking traffic. The complainant was later confronted at the 7-11 by Sgt Chadbourne, who degraded him and followed him out of the store then leaned against the complainant's car after being told not to.

I located and reviewed all BWC footage associated to the incident the complainant was referring to. The officers were on the scene of major crash involving serious injuries. The officers shut down the intersection to preserve the scene. [REDACTED] was about a block away from the crash scene when the complainant pulled up and was upset that he couldn't get to his apartment. [REDACTED] tried to provide the complainant directions on how he could get to his apartment. The complainant yelled something then drove off. (BWC footage marker added). The complainant then drove to [REDACTED] location and said the "roadblocks were illegal" and the officers should check with the DOT. When [REDACTED] told the complainant to keep moving the complainant said "No. Fuck," then sped off (BWC Marker added). In Sgt. Chadbourne's BWC footage, the complainant said something. Sgt. Chadbourne responded "Listen little guy you need to walk away." The complainant can be heard telling Sgt. Chadbourne to get away from his car. There is no clear video because Sgt. Chadbourne was wearing a high visibility vest.-CCI Theresa Person (6330)
