The complainant called in to file a complaint on officers who arrested him on 01-13-21 at ██████████. The complainant brought up numerous issues, including that officers surrounded his home, were in his backyard, knocked on his door for a lengthy amount of time, took him outside with no shoes when it was cold out, lied to him to get him to open the door, and pulled him out of his house to arrest him. The complainant was uncertain who the officer was that grabbed him and pulled him outside, but believed it was a sergeant. In reviewing BWC footage, ██████████ was the officer who took hold of the complainant to arrest him, with Sgt. John Chadbourne standing next to him.
