PROBABLE CAUSE AFFIDAVIT

Your Affiant, **Detective J. Kephart/6808**, herein referred to as I, is a Colorado State certified Peace Officer and has been for 5 years, all of which have been with the Colorado Springs Police Department (CSPD). Additionally, I was deputized by the El Paso County Sheriff's Office on July 31st, 2024. I am currently assigned to the Special Victims Section in the Investigations Division. My responsibilities include investigating sexual assault and domestic violence crimes. I state under oath that I have personal knowledge of the facts that are fully documented in CSPD case #**2025-00349793**. All addresses are located within the County of El Paso, State of Colorado, unless otherwise noted.

On 09/11/2025 at approximately 1515 hours, **Det. Sgt. J. Zahrobsky/2330** was contacted by the reporting party, identified through a law enforcement database check as [REDACTED] regarding a domestic violence incident that she was made aware of. [REDACTED] informed Sgt. Zahrobsky she had a personal friendship with both the suspect, identified through a law enforcement database check as **John Vincent Granillo DOB: 05/24/1987**, and the victim, identified through a law enforcement database check as [REDACTED]. [REDACTED] stated she learned that John and [REDACTED] were in a relationship, which she said she believed started a year prior and lasted for approximately 6 months. [REDACTED] said they kept their relationship hidden from others due to them both working at Colorado Springs Police Department (CSPD).

In October of 2024, John told [REDACTED] that he was in a relationship with [REDACTED] and that he had been lying to her about dating a nurse. In February of 2025, [REDACTED] noticed that [REDACTED] seemed to be isolating herself and was overly emotional. [REDACTED] told [REDACTED] she had been on one date with John and was not in a relationship with him beyond that. [REDACTED] also informed [REDACTED] that she believed John may have been following her, as well as spreading rumors about her to other members of the CSPD Metro division. John told [REDACTED] that [REDACTED] was the one following him and he had not been following her.

[REDACTED] informed both [REDACTED] and John that she did not want to be involved with what was going on between them and wished to only be involved with them professionally. [REDACTED] continued to confide in [REDACTED] about the issues between herself and John. [REDACTED] informed [REDACTED] that she had been followed by several vehicles she did not recognize and believed she may have had a tracker on her vehicle. [REDACTED] had her vehicle checked but was unable to locate any trackers.

[REDACTED] also disclosed that two of her personal vehicles had been vandalized. [REDACTED]'s Subaru Forester had been "keyed" on more than one occasion, as well as having its tires slashed on more than one occasion. [REDACTED] did not report any of the incidents with the Subaru Forester to law enforcement. [REDACTED]'s white Chevrolet Camaro was vandalized in 2024. [REDACTED] reported that incident and it was documented under **CSPD Case report 2024-01065720**.

It should be noted, on 09/12/2025 I reviewed CSPD Case report number 2024-01065720 as part of my investigation, I did not observe any indication of John being assigned to that case or completing any supplements in relation to that case. Furthermore, CSPD Case 2024-01065720 was inactivated on 06/26/2024 by then Acting Sgt. J. Ward/2110. On 07/04/2024 at approximately 07:06:37 hours, CSPD username **granilijo** accessed the case through CSPD's Law Enforcement Records Management System (LERMS) from workstation [REDACTED]. On 07/05/2024, the same username and workstation access the case 4 more times between [REDACTED] and [REDACTED].

approximately 16:17:24 hours and 16:22:03 hours. Additionally, there did not appear to be any associated cases. I later confirmed that username **granilijo** and workstation were both associated with John. Additionally, I was not able to locate any call screens or cases associated to John involving a White Chevrolet Camero and a shooting.

On 06/08/2026 at approximately 0659 hours, I served and released John with summons number 3137287 for 1st Degree Official Misconduct and Cybercrime.
