Summary:

On 08/13/19 at approximately 0015, I, Sergeant J. Waters, 1516, received a call from [REDACTED], DOB: 06/08/1966, at the Duty Desk of the Falcon Substation. [REDACTED] explained she had taken her son to Memorial's Children's Hospital earlier in the evening on this date for suicidal statements. [REDACTED] stated the doctors did not admit her son and she stayed on property with her 3 children while she used the phone to seek other care for her son who was in crisis. [REDACTED] became emotionally upset while speaking to me and began cussing and becoming loud as she explained the hospital staff and 3 CSPD Officers were rude to her and yelled at her. When I attempted to get clarification on what she was wanting and needing [REDACTED] became angry at me and stated she would re-contact Sergeant Miyakusu (Lieutenant Miyakusu). Approximately 1 hour later [REDACTED] called again and stated she wanted to file a complaint because the Officers were rude to her. I took [REDACTED] information and advised her I would call her later as she requested to update her. A call to her number at approximately 0200 resulted in no contact. Sergeant Farmer was notified and body worn camera footage was watched but no audio was heard on the footage. [REDACTED] called again at approximately 0500 and was informed a complaint would be forward to Internal Affairs.
