[REDACTED] was unaware the boys found the BB gun until officers came to her home. The officers spoke only to [REDACTED] not the other boy about the BB gun. At first, [REDACTED] denied using the BB gun. The officers threatened to take [REDACTED] to jail for lying if he didn't tell them the truth. [REDACTED] admitted to using the BB gun.
