Nature of Concern: Inappropriate Behavior of Officer during arrest. Claimant had Incident with Ex-husband. She was arrested on Domestic Violence, took kids from ex-husband's house. Took responsibility for arrest. [REDACTED] came to her house to have "conversation". Claimant was upset. Cooperated with officer. 3 days post-surgery for breast augmentation, hands behind her back was highly painful, boyfriend tried to explain this. Officer asked where she had surgery. Allowed her to sit with her hands in front of her in police cruiser. During the ride to the police station. He asked her about her surgery details (about her breasts) making claimant highly uncomfortable but she complied with his questions. Asked her about her eyes, making her uncomfortable, but she complied with his questions. Last thing was question about her age, "Don't take this the wrong way" you don't look 37. She complied with his questions She felt she was in a vulnerable State, and he asked highly inappropriate questions. Said she heard that there were already several complaints on the officer. Waited to report as she was afraid it would have affected her court case.

The call audio is attached to the email, in order to avoid having to have her explain the whole situation again, as she went into quite a bit of depth.

A check of police records showed [REDACTED] was not related to this call for service. BWC showed Ofc. Granillo asking [REDACTED] how old she was and then telling her she did not look 37.
