The following Affidavit is submitted to the Court to document the probable cause in support of a request for the issuance of an Arrest Warrant for **JOHN F TAYLOR III, DOB: 08/20/1986, AGE: 39, SSN:**

This offense is fully documented in Colorado Springs Police Department Report 2025-00453144 detailing the offense(s) of:

§18-7-302(1)(B), INDECENT EXPOSURE, CLASS 1 MISDEMEANOR (M1)

On 11/29/2025 at approximately 1907 hours, Your Affiant, Police Officer C. Salter, 7251, herein after referred to as I, was dispatched to the _____ located in the City of Colorado Springs, County of El Paso, State of Colorado in regards to a reported incident of public indecency that occurred in the parking lot of this location at approximately 1019 hours.

The incident was reported by an individual, later verbally identified and verified in law enforcement databases as **DOB: 12/16/2001**, who had contacted the Colorado Springs Communication Center stating a male, who was parked outside of the establishment in a Black Toyota 4Runner, bearing Colorado license plate _____ was inside of his vehicle masturbating.

_____ stated she had worked a shift at _____ from 0445 hours to 0800 hours on 11/29/2025. _____ informed me after completing her shift, she performed a workout and left the building at approximately 1019 hours.

_____ stated she parked her vehicle directly outside the front doors of the gym, near to a handicapped parking spot. _____ informed me as she went to her vehicle, she observed the black Toyota 4Runner with Colorado license plate _____ parked to the right of her vehicle. _____ stated the Toyota was positioned in such a way that it appeared to have either backed into the parking space or driven through it, with the front of the vehicle facing outward, which _____ noticed to be unusual.

As _____ walked past the Toyota, she glanced inside and observed a male individual seated in the driver's seat with his genitals exposed. _____ stated the individual was masturbating in his vehicle.

_____ described the male as a light complected black male with possible salt-and-pepper beard. _____ noted he was wearing a necklace and was wearing a blue flannel or plaid shirt. _____ stated she did not observe any clothing on the lower half of his body at the time he was masturbating. _____ noted Mr. Taylor's genitals, including his penis and testicles, were fully exposed.

_____ described his penis as circumcised and erect. _____ stated the individual appeared to notice her observing him masturbate when she walked past his car.

I conducted a law enforcement inquiry of the license plate _____ The inquiry yielded a return to a 2003 Black Toyota 4Runner with a registered owner as John Taylor, who resides at 265 Peck Court in Security, Colorado.

Further inquiries in law enforcement databases showed a **John Taylor DOB: 08/20/1986** was contacted and arrested by the El Paso County Sherriif's Office on 11/02/2025, related to a domestic violence incident at 265 Peck

Court. A photograph obtained in law enforcement databases of Mr. Taylor matched the description provided by [redacted] of the male who was masturbating in his vehicle.

I contacted El Paso County Deputy Sheriff Damuth #18025 and informed him of the investigation I was conducting. Deputy Sheriff Damuth agreed to drive by Mr. Taylor's residence to verify if the Black Toyota 4Runner bearing Colorado License Plate [redacted] was in the driveway of the residence. Deputy Sheriff Damuth confirmed the Toyota 4Runner was at 265 Peck Court.

On 11/30/2025, I returned to [redacted] to speak with the manager, later verbally identified and verified in law enforcement databases as [redacted] **DOB: 05/23/1994**; to review the video surveillance cameras at the location.

[redacted] informed me she did not have access to the camera system as it was managed through the security team, and a law enforcement request form would need to be completed for me to review the video footage.

Whilst speaking with [redacted] I asked her to verify if John Taylor was a member at the gym. [redacted] verified **John Taylor DOB: 08/20/1986** was a member at the gym. When [redacted] brought up Mr. Taylor's profile it displayed a photograph on their internal databases. The photograph I observed on [redacted] was the same person depicted in the photograph in law enforcement databases for Mr. Taylor.

[redacted] explained every time a member enters the gym, they scan their unique keycard to access the gym. [redacted] stated on 11/29/2025, Mr. Taylor's unique keycard was swiped to enter the gym at 0738 hours.

After leaving the [redacted] I received an email from [redacted] The email I received had the video surveillance footage from the day of the incident, 11/29/2025. The video footage depicted:

On 11/29/2025 at approximately 0727 hours, a Black Toyota 4Runner reversed into a parking bay at the [redacted] where [redacted] stated the suspect's vehicle was parked. The Toyota had a front newer model Colorado license plate, but the letters and number on the plate cannot be seen on video footage.

At approximately 0737 hours a male, who I can identify as Mr. Taylor, by comparing a law enforcement database photograph to the video footage of the male depicted on surveillance cameras, exits the driver's side of the Toyota and walks towards the gym.

At approximately 0738 hours, Mr. Taylor is observed to walk into the gym, swipe his unique key card to enter, which was verified by [redacted] internal databases Mr. Taylor had checked in, and walked to the main gym area.

At approximately 0915 hours, Mr. Taylor leaves the gym where he is seen wearing black gym shorts, a blue T-shirt and a grey zip-up jacket. Mr. Taylor can also be seen wearing a silver necklace, as described by [redacted]

At approximately 0916 hours, Mr. Taylor enters the driver's side door of the Toyota 4Runner with a set of keys in his hand and sits in the driver's seat. Mr. Taylor is alone in the vehicle.

At approximately 1020 hours, [redacted] walked to her vehicle, which was parked next to Mr. Taylor's vehicle, and [redacted] stares into Mr. Taylor's vehicle for a few seconds and enters her vehicle.

At approximately 1022 hours, [redacted] gets out of her vehicle and returns to the gym.

At approximately 1024 hours, [redacted] walked back to her vehicle and glanced into Mr. Taylor's vehicle. [redacted] then drives off out of the parking lot at 1025 hours.

At approximately 1032 hours, Mr. Taylor drives away after being in the parking lot for approximately 1 hour and 16 minutes.

The video surveillance footage corroborates [redacted] statement of events which had occurred. In addition to this, Mr. Taylor can be seen with a necklace around his neck as described by [redacted] Mr. Taylor is also wearing a blue T-shirt with a grey zip-up hoodie, but it was not plaid as described by [redacted]

However, the outfit Mr. Taylor was seen to be wearing at the time of the incident in the video footage is the same two-toned color originally described.

Officers were able to verify through law enforcement databases the suspect vehicle, the Toyota 4Runner, bearing Colorado license plate was driven by Mr. Taylor and was the only person in the vehicle when reported she had seen Mr. Taylor masturbating.

Through my investigation, I learned Mr. Taylor is a Teller County Deputy Sheriff and is currently employed as a Sworn Law Enforcement Officer in the State of Colorado.

Your Affiant would respectfully request that probable cause be found that **JOHN F TAYLOR III, DOB: 08/20/1986 SSN:** did, within the City of Security, County of El Paso, State of Colorado, commit in violation of the Colorado Revised Statutes 1973 as amended, the offense(s) of **§18-7-302(1)(B), INDECENT EXPOSURE, CLASS 1 MISDEMEANOR (M1).**
