The probable cause of the arrest of the above-named individual is as follows:

[On 06-09-2026 at approximately 20:08 hours officers responded to the parking lot of 3175 W Floyd Ave Building D on reports of assault. This location is in the city and county of Denver in the state of Colorado.

Officers on scene contacted the victim Katherine Alcon (DOB: 12-24-1987) who stated her husband Joshua Alcon (DOB: 01-28-1988) and her had been involved in a physical altercation. Joshua and Katherine have been together in an intimate relationships since 2004 with 5 Total children together. Joshua was identified by Katherine at the scene, in person, on BWC.

The altercation started when Joshua began to insult Katherine verbally. The altercation became physical when Joshua slapped Katherine twice with an open hand across her face. They began wrestling each other when Katherine fell on the bed and as a result of this Katherine's nose ring was ripped out of her nose.
