## PREDICATION

This truth verification examination was predicated upon a request by Undersheriff, Jon Horton, from the Morgan County Sheriff's Office; conducted by Certified Computer Stress Voice Analyzer and examiner Lieutenant Bill Dolan.

## SCOPE

The scope of this truth verification examination shall be limited to the subject's honesty when answering the questions in reference to an allegation while employed by the Washington County Sheriff's Office

## PRE-TEST INTERVIEW

During the pretest interview, the case information provided was discussed with Mr. Johnson. He stated he was not the one that initiated the first contact on Facebook messenger. We also discussed whether he had done this before.

## REPORT

On May 9<sup>th</sup>, 2022 I conducted an interview with Leotis Johnson about an incident that happened while he was a Deputy with the Washington County Sheriff's Office. The incident involved him and a female. He was accused of contacting the female after contacting her for a traffic violation. Mr. Johnson admits he did text back and forth with the female but was not the one that initiated the first contact.

## REPORT (Continued)

Mr. Johnson had spoken with Undersheriff Horton and agreed to the examination.

During the pretest interview, we formulated two questions to be used in the Zone of Comparison testing sequence. I conducted the interview, conducted the examination, and hereby submit the results to you. The following relevant questions were interspersed with irrelevant and control questions.

Questions #4 - "Were you the one that initiated contact with Jaiden on messenger?"  
The subject responded "No." - No deception indicated

Questions #6 - "Have you ever contacted anyone on messenger after a LE contact other than what you have told me?"  
The subject responded "No." - No deception indicated

Following the initial examination, a second examination was conducted utilizing the same test format as the initial examination, as well as the same relevant questions. The results of the second examination were the same as the initial examination

Based upon my training and experience, it is my opinion the subject responded truthfully to the relevant questions. A second opinion was requested by cold call.
