#### Summary:

Crimes Against Children supervisors requested Stetson Hills Shift II supervisors review calls for service [REDACTED] and [REDACTED] because of concerns that Officer Louis (Scott) Doll/3042 may have neglected key components of the investigation on those calls. An initial review of CFS notes, official reports, and BWC footage revealed possible violation of CSPD policies, which warrant further investigation.

---

On 02/04/25 I (Lt. Tim Stankey 1416) in took this complaint. I located BWC related to CFS# [REDACTED] and classified it as Complaint related. This footage was released to Commander Chacon and can be released to additional investigators upon request. I attempted to locate BWC footage related to [REDACTED] in both Axon and Polaris and was unable to locate any.

---

On April 28, 2025 IA received an email from Sgt. Falls regarding needing an extension on this Level 1. Sgt. Falls indicated that he had been out on military orders for 5 weeks (Feb 16 - March 21) and needed an extension to complete this Level 1.

I, Sgt. Ryan Jacobsen 2304, extended the due date out an additional five weeks. New due date is 06/01/2025.

---

On 05/02/25 I (Lt. Tim Stankey 1416) was contacted by Commander Cummings regarding this investigation. Commander Cummings indicated that he felt that during the level 1 investigation, the subject employee may have provided knowingly false information or was choosing to not recall specific information. Commander Cummings indicated that he would confer with DC Rosenoff but he felt the case should be changed to a level 2 and should be investigated by Internal Affairs. I did confirm with DC Rosenoff that she also agreed that the case should become a level 2 investigation. On 05/05/25 I changed the case type to a level 2 investigation and adjusted the due dates appropriately.

---

9/25/25: this level 2 was completed by DC Rosenoff and returned to IA, including a finding that his Departing from the Truth reached a clear and convincing standard. Offc. Doll has elected a BOR, which is pending.

---

On 12/19/25, Cmdr R. Chanza led a BOR, which ultimately upheld the sustained findings for all policy violations, and upheld the termination decision. See BOR25-0003.
