## Incident Summary

On the morning of 12/8/15 at about 0500 hrs, Inmate Christopher Inglese was brought into the jail and placed on a [REDACTED] by the nurse.

Deputies [REDACTED] [REDACTED] [REDACTED] and [REDACTED] along with Sgt Tracy were attempting to talk Inmate Christopher Inglese into changing into the [REDACTED]

Inglese was verbally non-compliant and displayed a physically resistant posture, stating that he would not change and that it would take more like 8 or 10 deputies to get him to changed.

Inglese stepped towards Sgt Tracy with his fist clenched and chest puffed out while he was trying to talk Inglese into complying with the deputies request.

Sgt Tracy attempted to gain Inglese's compliance, but when Inglese cussed at Sgt Tracy when he asked if there was anything he could do to gain his compliance, the deputies took control of Inglese and placed him in the Emergency Restraint Chair to avoid further conflict and possible aggression by Inglese.

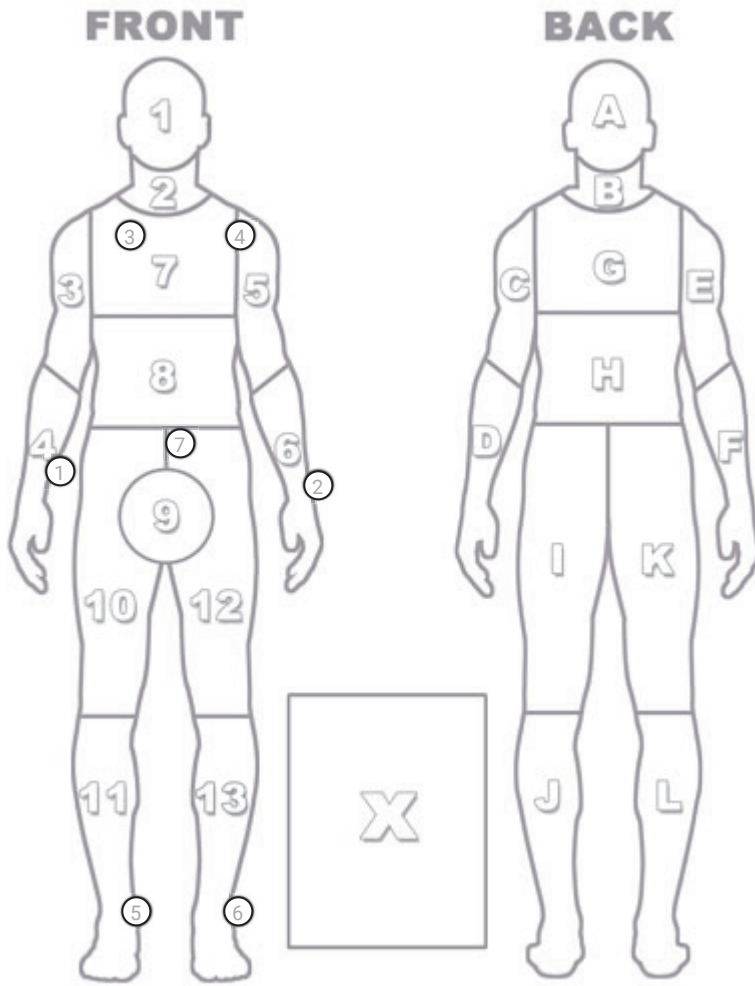
