This letter is to serve as an ORAL REPRIMAND for the violation(s) of Rules and Regulations Section 809, which reads as follows:


**RR-809            ROUGH OR CARELESS HANDLING OF CITY OR DEPARTMENTAL  
PROPERTY**

"Members shall use care in handling departmental equipment and property, and shall report immediately any that is lost, damaged, or in bad order. Any members who willfully or negligently loses, damages, or destroys department property shall be subject to a departmental hearing to determine disposition of such cases."

The recommendation that the officer receive an Oral Reprimand for this violation has been reviewed and approved.

This Oral Reprimand is a result of a preventable police vehicle accident on March 17, 2004.

**SUBJECT: Police Car Accident Complaint for Michael Nuanes 00109 (District Two Parking Lot) IAB Case # 2004040071**

I received a complaint regarding a police car accident involving Officer Michael Nuanes #00109 which occurred on 03/17/04 at approximately 2330 hours in the District Two parking lot. When the accident occurred Officer Nuanes brought it to my attention immediately. I conducted a preliminary scene investigation, took photographs and contacted TIB to respond to the scene. Officer Montoya #00132 completed the accident report and a statement and Officer Nuanes completed a statement. As stated in the attached packet Officer Nuanes was in the South parking lot of District Two loading his police equipment from his personal vehicle to his patrol car. While Officer Nuanes had his back turned the patrol unit (#A3859) rolled down the slightly graded lot Northbound into another, legally parked police unit (#A3840). Prior to my inspection, Officer Nuanes had backed his patrol car away from the second vehicle only enough to ascertain if any damage had been sustained by either vehicle. When I inspected his patrol unit the vehicle was in park and he couldn't recall if he had left the vehicle in gear or in neutral. The damage sustained by unit A3840 was minimal and there was no damage to unit A3859. My investigation revealed the damage and vehicle positions were consistent with the accident as described by Officer Nuanes. Additionally the damage was so minimal that it was reasonable that he backed his unit up to verify damage had actually occurred prior to reporting it. **This accident was** in my opinion **preventable**. It's most likely, while not certain, that Officer Nuanes either left his car in neutral or in gear. Regardless I have attached a copy of Municipal Code Section **54-441 Unattended Vehicles**. I believe **this ordinance is clearly applicable to this accident. It is a parking violation and carries 0 points.** It is however **applicable in accidents where the driver had control of the vehicle but was not in control of the vehicle as the actual accident occurred.** Additionally Officer Nuanes has no record of any previous accidents which I believe should be a mitigating factor to be considered when the administrative recommendation is made.

On April 11, 2004 I gave Officer Nuanes a written internal advisement explaining his rights as an Officer. Officer Nuanes read and signed the advisement and consented to write a statement concerning this matter. Officer Nuanes had nothing to add to his original statement. I conducted a follow up interview with a couple of questions and answers for clarification on some minor points which are also attached to this packet. On 04/21/04 I obtained a case number from Internal Affairs due to my belief the accident was preventable. The case number assigned was 2004040071.
