Building trust with the parents – asking to attend game night with the family, asking the family to attend his award ceremony, asking [REDACTED] to tell her dad and brother happy birthday

Access to and spending time alone with the child – paying her for private Brazilian Jiu Jitsu lessons, taking her to dinner, asking her to go on a ride-along with
