On 12/13/2018 at about 1200 hours, I was working as a 6th floor escort when I was approached by I/D [REDACTED] by the 6th floor control elevators. [REDACTED] asked me if spoke Spanish since he had some information about module 6A. On same day at about 1400 hours Counselor Austin Clark was teaching a class in Module 6A to [REDACTED] and few other inmates. After the class was done, Austin spoke to [REDACTED] and he told Austin that I/D Justice Andrew Espinoza (JCID P-01010180/[REDACTED] in cell 6A29 has full wi-fi on his tablet. [REDACTED] stated he also has access to Google, Face book and Porn-Hub. [REDACTED] stated that Espizona was communicating with someone on the outside and they are trying bringing drugs into the facility. I immediately contacted Sergeant M. DeNuzzi by telephone and advised him about the information provided by Austin. I decided to wait until Espizona could return the tablets back to us after lock down. At about 1800 hours, Espinoza returned the tablets since it was running low on batteries. I logged into the tablets but nothing was downloads by Espinoza. I also spoke to Jennifer VanDorn so Securus could track the tablets for any possible illegal activity.

**Disposition:** Case closed due to the lack of evidences.
