On January 1st, 2026 at approximately 5:52pm, I Officer Campbell(318607) responded to [REDACTED] [REDACTED] City of Aurora, County of Arapahoe, State of Colorado, regarding an assault complaint.

Upon arrival, I made contact with the reporting party, Rebecca Vega DOB (12-10-1999) who was standing outside the residence. Vega primarily spoke Spanish, so I utilized a telephone interpreter service to communicate with her. Through the interpreter, Vega provided the following account: She was at her boyfriend's house late identified by Colorado driver's license photo as Renzo Linan DOB (11-18-1991) when someone knocked on the door. She opened the door and the person, later identified by Colorado driver's license as Kim Nguyen DOB (2-8-1993), entered. Vega stated that Kim and her boyfriend Renzo began arguing in English, which Vega did not fully understand. During the argument, Kim spat in her face which landed on the right side of her face. Vega described this as the third time she had encountered Kim over the past few years, with previous incidents including Kim following her approximately two years ago and entering the house on a prior occasion.

Vega stated she did not personally know Kim but believed Kim had some type of problem with her. Vega described Kim as wearing gray pants and a black or navy sweater, with blonde hair, and appearing to be Asian or Chinese. Vega noted that Kim smelled strongly of alcohol. Vega confirmed her boyfriend, Renzo witnessed the incident and that he had cameras in his house. She stated she lived in [REDACTED] Colorado and provided her address. Vega expressed her desire to file a report and press charges against Kim. Vega was offered victim services and she declined.

I proceeded to the residence at to speak with Renzo. Renzo confirmed he was present during the incident. Renzo stated the following: He and Vega were at his house when Kim arrived to return an air compressor for tires. After Vega opened the door, Kim and Vega began arguing. Renzo attempted to separate them and told them to stop. He observed Kim approach Vega and spit at her. Kim stated he saw the spitting motion but did not see the saliva land on Vega. He immediately ordered Kim to leave his house multiple times. Renzo described the incident as stemming from jealousy. He provided Kim's phone number and stated she lived approximately three minutes away at the [REDACTED]. Renzo indicated Kim drove a white Subaru sedan or station wagon and lived on the first floor in an apartment facing the street, either in the second or third building.

Renzo showed me video footage from his exterior camera system. The footage, timestamped at approximately 4:05pm, showed Kim arriving in a white SUV and knocking on the door. The camera captured audio of the argument and Renzo repeatedly telling Kim to leave his house, but the camera angle did not capture the interior where the spitting allegedly occurred. Renzo agreed to send the video footage to me via a digital evidence link. The video showed Kim departing the residence after approximately four minutes. I attempted to contact Kim by telephone and I left a message. Kim returned my call at approximately 6:29pm. During our conversation, Kim stated she went to Renzo's house to return his tire air compressor. She claimed that after entering, Vega started "bickering" at her, and she asked what Vega's

problem was. Kim stated Renzo told her to leave and she complied. When I informed her that both Renzo and Vega reported she spit on Vega, Kim denied intentionally spitting on anyone. She stated they were yelling at each other and "maybe some of my spit came out because we were just yelling." Kim initially declined to provide her address or date of birth and questioned whether I had proof of the incident. After I explained the investigation and the potential for a warrant, she agreed to meet with me.

Kim provided a similar account to what she stated on the phone. She claimed she went to return the air compressor, Vega started speaking at her, and there was a language barrier. Kim stated she was yelling and has braces, suggesting "that's where this spit came from." She described standing close to Vega during the argument, with Renzo positioned between them. Kim stated she was yelling questions like "why are you tripping" but denied intentionally spitting at anyone. She acknowledged that spit may have come out while yelling and that she "felt spit like kind of just on my braces." Kim denied any jealousy and stated she and Renzo were "just friends." She claimed she had never met Vega before this incident.

Based on the statements from both Vega and Renzo, who provided consistent accounts as independently and Kim's acknowledgment that saliva may have been expelled during the argument, I determined probable cause existed for harassment 94-42(1). At approximately 7:05pm, I issued Kim a municipal summons for harassment #J326663 with a court date of February 2, 2026 at 8:00am. I advised Kim to have no contact with Vega and to leave if she encountered Vega at Renzo's residence. Kim acknowledged understanding and had no questions.

My body camera was activated per dept policy, nothing further.

My report was generated with the assistance of Draft One by Axon. I have reviewed my report in detail, made any necessary edits, and believe it to be an accurate summary of my recollection of reported events.
