## NARRATIVE

### SYNOPSIS:

On January 23rd 2020 at approximately 9:37 p.m., Valentin Martinez, was taken into custody as an accessory to the crime of escape, after Kendra Duran was found hiding in his home. The arrest came from incidents occurring at 2885 E Midway Blvd #204. Valentin was taken to the Broomfield County Detention Center, where he was booked and lodged.

### DETAILS:

On January 23rd 2020 at approximately 9:00p.m., I and other officers, responded to 2885 E Midway Blvd #204, to locate Kenra Duran (12/06/86) from an earlier domestic violence / restraining order violation call. Kendra Duran had been arrested around 11 am and placed in a patrol car. She was able to break out a window on the patrol car and escape from police custody. See Broomfield Police Report 2020-5232 for further details.

Valentin Martinez (12/11/71) answered the door. Valentin was aware that Kendra had escaped from police custody earlier in the day and was present for her escape. Valentin was advised that a phone ping indicated that Kendra was within the residence. Valentin denied that Kendra was within the residence. We asked if we could search for her and he allowed officers to check the residence. Valentin continued to say that Kendra must have his son's cell phone and that is why the phone pinged to the house. Valetin had the odor of an alcoholic beverage on his breath.

I went to the master bedroom and located Kendra hidden within the closet. Kendra was pulled out of the closet and placed into custody. Kendra was hiding in the same closet from the previous call for the escape earlier in the day. Kendra stated she had been back in the residence for several hours and Valentin had been talking with her in the bathroom when officers arrived to make contact. Kendra stated that she lives there and has lived there since 12/20/19, regardless of the restraining order.

Valentin attempted to act surprised when Kendra was located. Valentin continued to deny knowing that Kendra was in the residence. Valentin then went on to say that he was aware that Kendra had returned to the residence to gather her belongings. Valentin stated he thought she had left afterwards. Kendra's belongings were already collected during the previous call and Valentin was also aware of this.
