Narrative**INVESTIGATION**

On February 25, 2022, I portrayed myself in an undercover capacity as a 14-year-old female named "[REDACTED]" on the social media site Chat Hour. [REDACTED]'s profile showed she was "17" in Colorado. [REDACTED] received an unsolicited message from the user "[REDACTED]" stating, "Hey there ! I'm Tim in colorado, 6'4 blue eyes and dimples ..(wife is at work!;)) how are you??" (The suspect user will continue to be referred to as "Tim"). Tim's profile showed he was a 33-year-old male in the U.S.A.

[REDACTED] told Tim she was 14-years-old and lived in Lakewood, CO. Tim asked how tall and what her size was. She told him she was 5'1" and "32a." Tim wrote, "Omg you're so perfect !! I love small .. love sucking tiny hard nipples into my mouth :)."

[REDACTED] asked for his Snapchat username and he wrote "[REDACTED]". [REDACTED] also provided her Snapchat username.

I logged into my undercover Snapchat account and observed a friend request from the display name "Tim T" with the username "[REDACTED]". I portrayed myself as [REDACTED] and accepted the friend request. Tim messaged [REDACTED] asking, "You don't mind an older guy making you wet?;)." [REDACTED] requested a "selfie" and received a photo of a white male that matched the same male on Tim's profile picture on Chat Hour. [REDACTED] sent Tim a picture in return and Tim commented that he was "hard." [REDACTED] told Tim she had to go take a quiz and would be right back.

On February 25, 2022, when I attempted to message Tim on Snapchat at a later time, his Snapchat account was no longer available.

Tim later messaged [REDACTED] on Chat Hour explaining his wife came home and how he had to be careful. Tim asked, "Meet tomorrow ?"

On March 11, 2022, Lynsi asked if Tim had a Kik account. Tim provided her with the username "[REDACTED]". At approximately 9:05 a.m., I used my undercover Kik account (display name "[REDACTED]" with the username "[REDACTED]") and found the username "[REDACTED]" with the display name "Tim T". [REDACTED] sent a message stating, "Hey it's me." She asked where they would go and Tim suggested a "park" or "somewhere secluded." [REDACTED] asked what his "fav" to do was and Tim wrote, "Oral. I love love love eating a girl out till she cums." Tim also wrote, "Mmmm fuck/ Well I'd love to slide my tongue between your legs (winky face emoji)/ Up for a orgasm?"

I submitted a Preservation Request to Kik's law enforcement portal [REDACTED] for Tim's username "[REDACTED]".

Tim and [REDACTED] planned on meeting that day at Stone House Park located at 2900 South Estes Street Lakewood, Colorado 80227 at 11:00 a.m. Tim wrote he would let [REDACTED] know when he was five minutes away and wrote

about what he was going to do to her sexually, "Omg I'm gonna suck your clit into my mouth so hard (winky face)."

Jefferson County Sheriff's Office (JCSO) investigators conducted surveillance at the aforementioned address. Tim told [REDACTED] he would be in a black truck and sent her messages about how he was driving and on his way to the park. Tim messaged [REDACTED] saying he was in the area but had been pulled over for making an illegal U-turn. Jeffcom Dispatch did not have any traffic stops in the area so [REDACTED] asked Tim to prove he was stopped and to send a picture. Tim did not reply and changed his display name to "TT" on Kik. Tim also deleted his Chat Hour account.

The above communications between the suspect and the teen persona took place sporadically from February 25, 2022, to March 11, 2022, at 11139 Bradford Road, County of Jefferson and State of Colorado.

On March 23, 2022, I wrote a Production of Records (POR) for the suspect's Kik account [REDACTED]. It was reviewed and granted by the Honorable Judge Carol Glowinsky. I submitted the POR through the Kik Law Enforcement portal and as a case report attachment with the Jefferson County Sheriff's Office Records unit.

While I portrayed myself as the underage teenage female "[REDACTED]" on the social media site Chat Hour, [REDACTED] had three saved pictures of herself on her Chat Hour account "[REDACTED]". The first two pictures showed her in front of the Chatfield Senior High School sign and the last one showed her holding a stuffed Panda toy.
