LETTER OF REPRIMAND

SUBJECT: Deputy Myer

On 4/22/26, we had an inmate being moved to housing. This inmate was in full restraints due to Admin Segregation status. During this movement, the inmate began refusing to move. Deputy Myer, you called over the radio stating, "Push her!" in reference to the inmate. This is not standard practice for Detention Deputies nor is it a technique that is trained in Defensive Tactics. Deputy Myer, your statement is in violation of the following policy:

CODE OF CONDUCT

METHOD:

Conduct Unbecoming: Members will conduct themselves at all times both on and off duty in a manner which reflects most favorably on the Sheriff's Office. Members will not engage in conduct prejudicial to good order and discipline or in conduct unbecoming a law enforcement officer. Members will not participate in any immoral, indecent, lewd, or disorderly conduct. Members will not utter any disrespectful, mutinous, insolent, abusive language or offensive gestures toward another member, supervisor, subordinate, staff officer or the public

You and I had a discussion about your statement after the fact. I explained that this statement was not acceptable and not the culture of our agency.

As always, you are a valuable member of the team, however we have had several discussions about your unprofessionalism and offensive statements. This is not how we expect deputies to represent themselves.

I am assigning you three CorrectionsOne trainings (Career Professionalism, Corrections Liability, and Officer Liability) which will need to be completed one month from our discussion (5/24/26).

LETTER OF REPRIMAND

SUBJECT: Deputy Myer

On 2/1/26, I received a grievance from an inmate that was in pertinence to Deputy T. Myer. The grievance detailed an incident that occurred on 1/29/26 in which Deputy Myer swore at an inmate, told them that they would be written up for requesting a grievance, and slammed their window slider closed. I reviewed cameras and observed that on 1/29/26 at approximately 1738 hours, Deputy Myer was speaking to the inmate in what appeared to be an agitated tone (pointed finger and tense body posture) before slamming their window slider closed. He then completed a security check before returning to the cell, opening the window, and exchanging a few more words with him. Deputy Myer's next day on was 2/6/26, so I planned to have a discussion with him.

On 2/6/26, Cpl. Ward, Cpl. Mossbrucker, Cpl. Jenkins, Cpl. Anderson, and I held Deputy Myer back after briefing. I asked him to tell me what happened during the incident on 1/29/26. He told me that the inmate was shouting and causing a disturbance in the pod so he "slapped" his window slider closed. I asked him if he had made any derogatory comments towards the inmate and he told me that he didn't. I also asked if he had told the inmate that he would be getting a violation for asking for a grievance. He told me that he warned him against misusing the intercom system, but did not prevent him from filing a grievance. I asked him about the window slider and why it wasn't documented. He told me that he wasn't sure that it needed to be documented. Cpl. Ward brought up that on that day, Deputy Myer had called to inform him that he had closed and inmates window slider and that he told him to enter it on GCID. Deputy Myer said that he did not remember that and that he likely forgot. I told Deputy Myer that between the grievance, the camera footage, and our discussion that his actions constituted a violation of the Code of Conduct P&P as well as the Window Slider SOG.

I am having him write an essay on the importance of maintaining professionalism both on and off duty and how our conduct reflects on the agency as a whole. I am assigning it on 2/6/26 with a due date of 3/4/25.

LETTER OF COUNSEL

SUBJECT: Deputy T. Myer

While working 3rd floor control with Deputy T. Myer, Deputy T. Irvin, we (Cpl. E. Diaz and Sgt. R. Nye) were discussing living in Florida. Deputy Myer stated that, in Jacksonville you have to watch out for "the chimps." Everyone in the room immediately quieted down and became uncomfortable, however I was unsure if maybe we had misheard him. Later in the conversation, Deputy Myer began talking about different dialects in the country and brought up both "basketball speak" and "chimpin'." This further made everyone in the room uncomfortable. On a later date, Deputy Myer was conversing with Deputy Brinkdopke and he asked him if he had any kids. Deputy Brinkdopke explained that he had a step-kid, but that was all. Deputy Myer told him that he should have kids because he "has the genes for it." Deputy Brinkdopke did not understand what was meant by this, so he asked for clarification. Deputy Myer stated that they "wrote a book on it." When Deputy Brinkdopke reported this conversation to us, he described the overall feeling as uncomfortable. He also stated that he believed Deputy Myer was making these comments in relation to his race. On 11/19/2025, we had Deputy Myer hang back after briefing to discuss these comments. We explained to Deputy Myer that this conduct is unacceptable and has no place in law enforcement/our agency. We further explained that, regardless of his intent, these statements were perceived as offensive. Deputy Myer stated that he understood that statements of this nature would not be tolerated and that he would not allow this to happen again. We have also assigned Deputy Myer Anti-Bias and Anti-Harassment trainings on CorrectionsOne Academy. He will be expected to complete these as well as rewatch the GCSO Workplace Harassment training no later than one month from signing this letter (12/19/2025).

On June 29th, 2026, Ty Myer, a non-POST certified Detention Deputy, was the subject of an internal affairs investigation that involved him daring or challenging an inmate to open the cell door of another inmate's cell while that inmate was using the toilet in his cell. During the investigation, it was determined that two policies were violated: GCSO Code of Conduct and GCSO Fraternization with Inmates. There is a sustained finding of him violating these policies through his actions. On July 7th, 2026, Ty Myer was terminated for violating these policies through his actions.

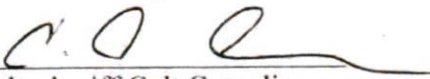

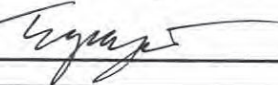

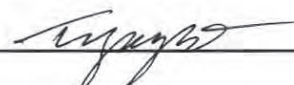
