I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 10/01/2024 at 1:12 am at or near the location of 10000 E YALE AVE in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:

[On 10-01-24 at approximately 0112 hours, Officers responded to 10000 E Yale Ave apt 29, on a report of a domestic violence. This location is in the City and County of Denver, State of Colorado.

Upon arrival officers spoke to the victim identified as Shaqueena Sturdivant (DOB 09-27-84) who related to officers the suspect identified as Willie Smalls (DOB 05-02-90) had strangled her. Shaqueena said Willie wrapped his left arm around her neck causing her pain and at one point made her urinate on herself. Shaqueena stated the strangulation lasted approximately 1 minute and rated the amount of pressure on her neck a 10 on a scale of 1-10. Shaqueena told officers that Willie was still located inside the residence. Officers observed a red mark on the right side of Shaqueena's neck. Officers knocked on the door to the apartment and a male opened the door. Officers called out to him with the name of Smalls, and he responded confirming that was his name. Officers took Willie into custody without incident.]
