ON 092922 AT APPROXIMATELY 2245 HOURS, I WAS PATROLLING THE AREA SURROUNDING THE LEVEL 1 ARCADE AT 807 17TH STREET. THIS LOCATION IS CURRENTLY THE PRIMARY AREA FOR A PROBLEM ORIENTED POLICING (POP) CASE. THE PARKING LOT IS FREQUENTED BY DRUG USERS, DEALERS, STOLEN VEHICLES, AND PEOPLE WITH WARRANTS OR WANTS. I OBSERVED A RED DODGE PICKUP PULLING INTO THE PARKING LOT, AND RAN THE LICENSE PLATE (BEKQ74). I THEN VIEWED THE REGISTERED OWNER, DANIEL GOOGIN, AND SAW THAT HE HAD A COLORADO INTEGRATED CRIMINAL JUSTICE INFORMATION SYSTEM (CICJIS) WARRANT FOR CRIMINAL MISCHIEF. MYSELF AND OTHER OFFICERS CONTACTED GOOGIN AT THE FRONT DOOR OF THE ARCADE AS HE WAS STANDING NEAR HIS TRUCK. I ASKED IF HIS NAME WAS DANIEL, AND HE SAID YES. DANIEL MATCHED HIS SPILLMAN PHOTO. I THEN DETAINED DANIEL IN ORDER TO CONFIRM THE WARRANT.

FROM HIS PERSON. THE FIREARM WAS CLEAR AND PLACED INTO SAFEKEEPING. UPON CONFIRMING THE WARRANT, I SEARCHED DANIEL INCIDENT TO ARREST. IN HIS POCKET, DANIEL HAD TWO CIGARETTE BOXES. ONE OF THE BOXES MADE A SOUND AS IF THERE WERE A HARD OBJECT INSIDE, AND NOT CIGARETTES. WITH MY KNOWLEDGE AND EXPERIENCE, I KNOW THAT PEOPLE TEND TO KEEP NARCOTICS INSIDE CIGARETTE BOXES. I FOUND A SMALL GLASS JAR OF SUSPECTED METHAMPHETAMINE, WHICH WAS LATER WEIGHED AND TESTED AT THE GREELEY POLICE DEPARTMENT. THE SUBSTANCE TESTED PRESUMPTIVE POSITIVE FOR METHAMPHETAMINE AND WEIGHED 1.9 GRAMS WITHOUT THE CONTAINER. DANIEL WAS ADVISED THAT HE WAS BEING CHARGED WITH POSSESSION OF A CONTROLLED SUBSTANCE, AND UPON READING HIS MIRANDA WARNING, ELECTED NOT TO SPEAK TO ME.

DANIEL WAS TRANSPORTED TO THE NORTH JAIL COMPLEX (NJC) FOR THE WARRANT AND THE DRUG CHARGE. CASE CLOSED BY ARREST. NO FURTHER ACTION.

OFFICER LOPEZ (GP0489) WAS PARKED JUST OUTSIDE OF THE PARKING LOT AND OBSERVED A RED PICKUP TRUCK ENTER THE LOT. THE PICKUP TRUCK, BEARING PLATE BEKQ74, REGISTERED TO A DANIEL GOOGIN, THE DEFENDANT. OFFICER LOPEZ OBSERVED THAT THE DEFENDANT HAD A LOCAL NAMES FILE, AND ALSO OBSERVED THAT HE HAD A WARRANT FOR CRIMINAL MISCHIEF. THIS WARRANT WAS NO CONFIRMATION REQUIRED UNDER DOCKET # C0622022M001969. OFFICER LOPEZ AND OTHER OFFICERS OBSERVED THE DEFENDANT STANDING OUTSIDE THE FRONT DOOR OF THE ARCADE, NEXT TO HIS PICKUP TRUCK. OFFICER LOPEZ MADE A POSITIVE IDENTIFICATION BASED ON THE SPILLMAN PHOTO AND DETAINED THE DEFENDANT. THE DEFENDANT DID IDENTIFY HIMSELF AS DANIEL GOOGIN, AND WAS PLACED IN THE BACK OF A PATROL CAR.

UPON VERIFYING THE WARRANT AND SENDING IT OVER TO THE JAIL, OFFICER LOPEZ CONDUCTED A SEARCH INCIDENT TO ARREST ON THE DEFENDANT. THE DEFENDANT HAD TWO SMALL CAMEL CIGARETTE BOXES IN HIS POCKET AND OFFICER LOPEZ, UPON OBSERVING THESE, DISCOVERED A GLASS JAR WITH SUSPECTED CRYSTAL METHAMPHETAMINE AND A PLASTIC STRAW IN ONE OF THEM. THIS WOULD LATER BE TESTED AT THE GREELEY POLICE DEPARTMENT, WHERE IT WAS PRESUMPTIVE POSITIVE FOR AMPHETAMINES. IT WEIGHED APPROXIMATELY 1.9 GRAMS, NOT INCLUDING PACKAGING MATERIALS.

THE DEFENDANT WAS ADVISED OF HIS MIRANDA AND ELECTED NOT TO SPEAK. THE DEFENDANT WAS TRANSPORTED TO WELD COUNTY JAIL AND BOOKED WITHOUT INCIDENT.

I AM CREATING THIS SUPPLEMENT TO DOCUMENT IN GREATER DETAIL, INFORMATION ON THE SUSPECT IN THIS CASE, DANIEL GOOGIN, AND THE ACTIONS PERFORMED BY MYSELF WITH CHARGES.

ON 092922 AT 2303 HOURS, I OBSERVED A RED PICKUP TRUCK ENTERING THE PARKING LOT OF 807 17TH ST, THE LEVEL 1 ARCADE. THE ARCADE HAS BEEN A CENTRAL POINT OF ISSUES, WHEREIN OFFICERS HAVE ENCOUNTERED NARCOTICS, STOLEN VEHICLES, WANTED FUGITIVES, AND GENERALLY SUSPICIOUS ACTIVITY. UPON RUNNING THE LICENSE PLATE, I SAW THAT THE RO, DANIEL GOOGIN, HAD A WARRANT FOR HIS ARREST. I ASKED SEVERAL OFFICERS WHO WERE NEARBY TO ASSIST ME IN EFFECTING THE ARREST OF DANIEL. I CHECKED SPILLMAN FOR A LOCAL FILE ON DANIEL, IN WHICH I DID FIND A PHOTO. I MADE NOTE OF THE PICTURE ATTACHED TO THE LOCAL PROFILE OF DANIEL IN SPILLMAN, AND I MOVED TO CONTACT THE TRUCK.

I OBSERVED DANIEL STANDING OUTSIDE OF HIS TRUCK NEXT TO THE FRONT DOOR OF THE ARCADE, SMOKING A CIGARETTE. I ASKED DANIEL IF THE TRUCK BELONGED TO HIM, AND IF HIS NAME WAS DANIEL. HE SAID YES, AND I PLACED HIM UNDER ARREST FOR THE WARRANT. I ESCORTED DANIEL ACROSS THE PARKING LOT TO MY MARKED PATROL VEHICLE. I ASKED DISPATCH TO RUN DANIEL, AND CONFIRM THE WARRANT IF NEEDED. DANIEL AND I MAINTAINED A CONVERSATIONAL TONE AS I TOLD HIM THAT I KNEW HE HAD A WARRANT AND

I WAS WAITING FOR DISPATCH TO CONFIRM IT. AS I WAS AWAITING DISPATCH, DANIEL INFORMED ME THAT HE WAS CARRYING A CONCEALED FIREARM. I ASKED DANIEL WHERE IT WAS, AND DANIEL GESTURED WITH HIS HEAD AND TOLD ME VERBALLY THAT IT WAS IN HIS WAISTBAND IN FRONT.

I REACHED INTO DANIEL'S PANTS, AND RECOVERED A GLOCK 9MM HANDGUN, AND I PASSED IT TO MY COVER OFFICER. I THEN CONDUCTED A PAT DOWN SEARCH OF DANIEL'S PERSON AND VERIFIED THERE WERE NO MORE WEAPONS. THE FIREARM WAS RAN THROUGH DISPATCH, AND IT DID NOT COME BACK WITH ANY ALERTS OR OTHER INDICATORS. I COLLECTED DANIEL'S WALLET AND A BOX OF CIGARETTES OFF OF HIS PERSON BEFORE PLACING HIM BACK INSIDE THE PATROL VEHICLE. I NOTICED WHILE MOVING THE BOX OF CIGARETTES, THAT THERE WAS A SOUND AND FEEL NOT CONSISTENT WITH A BOX OF CIGARETTES. INSIDE THE BOX OF CIGARETTES WAS A SMALL AMOUNT OF METHAMPHETAMINE. THE METHAMPHETAMINE WAS TESTED PRESUMPTIVE POSITIVE AND WEIGHED 1.9G. DANIEL WAS CHARGED FOR THIS LATER, AS DOCUMENTED IN THE ORIGINAL REPORT.

AFTER DANIEL WAS PLACED UNDER ARREST, I DID TRANSPORT HIM TO THE NORTH JAIL COMPLEX (NJC). WHILE EN ROUTE, I ASKED THE GREELEY POLICE RECORDS DIVISION TO PROVIDE ME WITH A CRIMINAL HISTORY OF DANIEL. THIS WAS DUE TO THE FIREARM POSSESSION, AND TO ENSURE DANIEL WAS LAWFULLY CARRYING THE HANDGUN. DANIEL DID TELL ME THAT HE WAS CURRENTLY IN CRIMINAL PROCEEDINGS FOR A FELONY CHARGE, BUT HE HAD NOT BEEN CONVICTED OF ANYTHING THAT WOULD DISQUALIFY HIM. I CANNOT RECALL IF DANIEL TOLD ME THAT HE WAS A CONCEALED PERMIT HOLD. TO THE BEST OF MY KNOWLEDGE, AT SOME POINT AFTER ARRIVING AT NJC, I DID SEE A CONCEALED CARRY PERMIT IN DANIEL'S WALLET. THE PERMIT WAS VALID TO MY VIEW, HOWEVER I DID NOT RUN IT THROUGH DISPATCH. I ALSO REVIEWED DANIEL'S CRIMINAL HISTORY, AND FOUND THAT HE HAD NO CONVICTIONS WHICH WOULD PROHIBIT HIM FROM OWNING OR CARRYING A FIREARM.

DANIEL WAS NOT CITED FOR ANY FIREARM OFFENSES BECAUSE OF THIS. HIS FIREARM WAS PLACED IN SAFEKEEPING AT THE GREELEY POLICE DEPARTMENT UNDER HIS NAME.

THIS ENDS THIS SUPPLEMENTAL REPORT. CASE STATUS UNCHANGED.
